

# October Meeting Event

## The Great Seismic Headache

#### **Presentation Summary:**

The course is based on the International Building Code 2015 edition and the ASCE 7 standard 2010 edition. The course is designed to raise awareness of the potential risks associated with non-structural failures and the costly consequences associated with those failures. Attendees will be guided down a path to discover why restraint requirements exist, what are the restraint requirements, what happens when restraints are not properly designed and installed, and understand the key roles that each party on the design and installation team play in assuring compliance.

Joel A. Davis, Sr., PE

#### **CEO – Synergy Engineering**



Mr. Davis is a founding partner in Synergy Engineering, and has been a driving force in the industry, working diligently to re-shape the concept of seismic restraint for non-structural components through marketing and education.

Mr. Davis has over 25 years of experience in the HVAC business. The early portion of that experience included various roles on the contractor side. Eight years were spent learning the trade working as a helper, mechanic, foreman, superintendent, estimator, assistant project manager, and project manager.

Mr. Davis worked as a manufacturer's representative serving North & South Carolina, Georgia and Eastern Tennessee. His experience includes roles as a Product Specialist, Territory Manager, and Vice President helping guide the industries approach to the seismic restraint of mechanical, electrical, and plumbing systems during the transition from the 1999 SBC to its current edition of the IBC 2015.

Mr. Davis is an active member of the Southern Piedmont Chapter of ASHRAE. He is a past president of the Southern Piedmont Chapter of ASHRAE and also the Pinnacle award recipient for the 2002-2003 campaign years. He is a licensed professional engineer in the states of North Carolina, South Carolina, Alabama, Missouri, and Florida.

There are individuals who are trying to gut the building codes of requirements for proper construction and energy conservation. Randy Jones and Dennis Knight have been combating this in Columbia by providing their input on senate bill 579.

Steve Marek gave us an update on Technical Committee 7.3, Operation and Maintenance Management. Presentations can be downloaded from the website. Any ASHRAE member can be a corresponding member of a TC.

Bruce Hunn, PHD, DL, gave an outstanding presentation on Building Energy Quotient, bEQ, at our September meeting. bEQ gives a numerical rating to a comparison of a specific building to a range of typical buildings. Other systems of rating include LEED and Energy Star. All over the world there are different ways of scoring buildings. bEQ compliments these.

Do not compromise indoor air quality (IAQ) to improve energy performance.

bEQ provides recommendations for improving score and provides means for pushing buildings into highperformance category. bEQ is based solely on energy, not recycling. It provides a consistent rating system for existing and new buildings.

The Energy Star system scores from 0 to 100. Designation for an energy star rating requires a score above 75. bEQ pushes energy performance higher than the Energy Star system. It pushes toward net-zero.

One bEQ rating is "as-designed". This is based on modeling assuming standard occupancy using an 8760-hour program. The program compares the specific building to all other buildings of its type.

The other rating is "in-operation" and considers metered energy consumption.

The rating scale is zero-based (zero net energy). The score can go below zero (energy-producing). A score of 100 is the median. Higher than 100 is worse than the median. The comparison is made against similar buildings, not against a building with no windows, etc. The "average" building is calculated based on construction in the year 2000.

The score based on energy use (EU) is:

[(EU simulated)/(EU baseline)] x 100.

The scoring system compares buildings of the same use and with the same location and climate so that a building is not penalized for construction in a severe climate or for a use which would obviously consume more energy.

Energy saving opportunity follows ASHRAE level 1 Energy Audit procedure.

Submission for bEQ certification requires an ASHRAE certified professional or a PE in the area of jurisdiction. The bEQ web portal provides a streamlined way to submit information.

A bEQ score is available at no cost. The audit report and data sheets cannot be printed out without payment of a fee.

An expansion of the program is underway. Institutions will be able to obtain an EQ for the whole campus. Cities will be able to obtain an EQ for the combined area of government buildings.

Dennis Knight is a certified Building Energy Modeling Professional (BEMP) and is qualified to submit the information for bEQ certification.
